TITLE: Walk A Mile in Her Shoes

ORIGINATOR: Campus and Community Affairs Committee

WHEREAS: Campus and Community Affairs Committee is requesting funding for Walk A mile in Her Shoes, and

TITLE: Pause For A Cause
